### **Benevolent Fund Policies and Guidelines**

- The Benevolent Fund shall receive income from the receipt of special contributions by individuals and/or families wishing to make a donation to the Fund via Benevolent collections
- In order to comply with IRS regulations concerning charitable contributions, all gifts to the Benevolent Fund must be unconditional and without personal benefit to the donor.

A church can give cash to a needy person from the benevolence fund; however, as with all other benevolent gifts, the purpose of the funds must be to provide for the basic necessities of life. For example, a church could make a cash gift to a family who recently suffered a loss due to death or natural disaster.

### **Benevolent Fund Guidelines For Church**

Identify employee or pastor of church who is responsible for approving benevolent gifts. Identify amounts or types of gifts that can be made without approval from the Board. Whenever payments are made from the benevolence fund, the church should maintain documentation to show that the benevolence policy was followed.

### **Has Your Church Had An Increase In Requests For ...**

Benevolent Fund must be unconditional and without personal benefit to the donor. Contributions to the Benevolent Fund may not be earmarked or otherwise designated for particular purposes or recipients. The leadership of Faith Community Church may choose, at its discretion, to decline certain contributions that are designated or earmarked.

### **Benevolence Church Policy and Procedure**

The purpose of ABC Church's benevolence fund is meet qualifying individual's basic needs. Funds designed by individuals, by the Church or by other sources for the Benevolence Ministry shall comprise the funds available. No money will be borrowed to continue giving help, nor promises made for ongoing help without a certain assurance of funds being available.

First and foremost, private charity between individuals will be encouraged and the Church may facilitate individuals carrying out private benevolence (i.e. no receipts are issued and funds do not pass through any bank accounts attributed to the Church).
